Before starting the activation

- Have your BIL Suisse
 Activation letter containing
 your UserID and cryptogram
 and the initial password
 received through your RM
 within reach.
- Download the BIL Suisse Authenticator App from the Google Play or App Store on your mobile phone.






Follow these steps to activate the BIL Suisse Authenticator




Login to BIL Suisse

Page. Ensure this is
done on a computer
or laptop



Open the BIL Suisse Authenticator App on your phone and select "Scan Code"



Allow the App to access the camera on your device



Scan the
cryptogram of your
activation letter (in
case of printing
ensure that the
cryptogram is in
colour)



Enter the code displayed in the App in E-Banking







Complete steps to activate the BIL Suisse Authenticator App











Choose a 6 digit PIN to secure the Authenticator App and activate Touchor Face-ID to simplify the App access (Please memorize your PIN as it cannot be reset)

Scan the cryptogram displayed on your E-Banking screen with the Authenticator App

Insert the code in E-Banking

Allow on the
Authenticator App the
sending of push
notifications to ensure a
smooth user experience
